Participants understands that they must obtain all of the required permits to sell food at Chesapeake City Park and will contact the Chesapeake Department of Health (757-382-8672) and the Chesapeake Commissioner of the Revenue (757-382-6620) **NO Later than May 15, 2010.**

- Hampton Roads Pride reserves the right to determine which vendors and informational organizations are appropriate for "Out in the Park".
- Vendor Agrees to display and or sell **ONLY** items/information that are in **NO WAY** vulgar, offensive, obscene, or inappropriate for an "All Ages" Festival.
- Space location is determined at the discretion of Hampton Roads Pride. Participants may not Share or Sublet space without prior approval of the Board of Directors.
- There will be no refunds for inclement weather. The event will be rescheduled to the nearest available date, and your space will be reserved.
- The Participant hereto expressly releases Hampton Roads Pride, its Membership, Officers and Board of Directors; The City of Chesapeake Parks and Recreation Department and its Agents from any and all liability for damages, loss, injury or consequences to persons or property for any cause whatsoever. The Participant furthermore agrees to indemnify and hold harmless the above named parties against any and all claims resulting from any and all connections with the use of the festival site and adjacent grounds associated with the festival.
- The Participant is responsible for their own conduct and the conduct of employees also responsible for materials, products, merchandise, equipment; also responsible for damages to their own site or others property.
